

MOBILE DYSPHAGIA DIAGNOSTICS

June is Dysphagia Awareness Month. Did you know that the prevalence of dysphagia has been estimated to be as high as 68% of all residents in long term care facilities? It is estimated that over 45% of SNF residents with dementia suffer from dysphagia, and those who can not follow 1 step directions have a 57% increased chance of aspirating thin liquids. As alarming as these statistics may be, speech-language pathologists have been specially trained to diagnose and treat swallowing disorders. However, bedside swallowing exams have a 70% false positive rate leading to overly restrictive diets potentially leading to dehydration, malnutrition, electrolyte imbalance, and UTIs, while having a 14% false negative rate and potentially missing silent aspiration completely, therefore the use of instrumental swallowing assessments is imperative.

Sepsis, CHF, URIs, UTIs, and electrolyte imbalance account for 78% of all 30-day SNF re-hospitalizations, and have all been deemed as potentially avoidable with careful monitoring of and adherence to patient fluid and nutrient intake, and by following appropriate positioning of residents with swallowing problems to avoid aspiration that could lead to pneumonia. Aspiration pneumonia is the leading cause of death and the most common

complication arising from dysphagia for long term care residents. The average cost of a re-hospitalization due to any of the aforementioned conditions can cost a facility approximately \$30,000. The cost to keep 1 resident on thickened liquids for 1 year can cost a facility between \$2,000-\$7,000 annually. The cost of managing a patient with a feeding tube, which for many has been the primary treatment option for dysphagia is reported to average over \$31,000 per patient per year.

A mobile swallow study done for a few hundred bucks in your facility to visualize a resident's swallowing physiology and make appropriate recommendations doesn't so bad after all.

ADDRESSING SOCIAL ISOLATION & LONELINESS IN OLDER ADULTS

The Amherst Center for Senior Services is supporting a national campaign led by the National Association of Area Agencies on Aging (n4a), in collaboration with the AARP Foundation, to help raise awareness of the growing problem of social isolation and loneliness in older adults. It is estimated that one in five adults over age 50 are affected by isolation, a problem that has been associated with higher rates of chronic disease, depression, dementia and death.

The Center provides a supportive environment for every dimension of wellness: physical, emotional, social, intellectual and vocational. Center staff help address the negative health effects of isolation and loneliness on a daily basis by connecting members and their families to area resources and can also provide an assessment for home-based services. Their new **Senior Center on the Move** program coordinates engaging

programs at area senior complexes and gives residents a sampling of what they can find at the Center.

"Because our agency is on the frontlines of helping older adults live with dignity and independence in their homes, connecting them to an array of in-home services so vital to their well-being, we are often the first to realize that an older adult is isolated and lonely," said Pamela Krawczyk, Director of the Amherst Center for Senior Services.


